Call to Order/Roll Call

Approval of Minutes

- A motion was made by M. Christie and seconded by S. Greene to approve the 2/17/14 Meeting Minutes.

Discussion

- B. Carney and B. Emmons discussed the status of host installation and the PSAP group prioritization to go-live on the system. PSAPs were prioritized based on volume and critical needs. The first PSAPs are expected to be deployed on the system by September. B. Carney also stated that a contract extension for Cleveland is being explored because the new structure for their PSAP is not projected to be ready until March 2015. A status update on Strongsville's PSAP was also discussed.
- B. Emmons provided an update to the Committee regarding the 911 GIS Map. The Cuyahoga County GIS information is currently being reconciled with the MSAG to alleviate discrepancies. Additionally, County GIS is in the process of creating a website for addressing agencies to update GIS information.
- The group discussed voice recorder capabilities and parameters for the 911 System, including; the recording of calls transferred between

agencies, ownership of the recordings, and public records requests for the recordings. B Emmons stated the the 911 System comes with a limited recording capability, but it is not intended to replace an agency's long term voice recorder. B. Carney recommended that the 911 TAC explore this matter further.

- S. Greene discussed enhanced location information for 911 calls from multi-level buildings (e.g. the floor a 911 call is originating from). S. Greene to email NENA-related information to the Committee for review. B Emmons stated that Kentucky has already approved legislation to require this information.

Other Business

- B. Carney provided an update to the Committee concerning the approval of Cleveland to receive wireless 911 calls directly.
- S. Greene informed the Committee of R. Hannay's retirement from the OSHP and the 911 TAC.
- B. Carney updated the Committee that Ken Mills was recently appointed as the new Director of the Department of Public Safety and Justice Services for Cuyahoga County.
